To the Honorable Mayor Kendall and Keene City Council Members,

Hello. My name is Paula Sousa and I own a duplex at 22 Middle Street. This letter is a request to amend the city code relating to the overnight parking restriction on Middle Street. My request is to allow residents with current overnight parking permits to be able to park overnight at the three metered parking spaces on Middle Street (specifically, during the overnight parking season, May-Oct). Currently, Middle Street is considered part of the Downtown Business District, which does not allow overnight parking between the hours of 2 am and 6 am. Our original permitted parking spaces were in the Elm Street Lot but we lost those spaces when the lot was developed for the new Fire Station; we were moved to the Commercial Street Lot (behind the Colonial Theater), a significantly longer distance from our house.

SUBJECT: Goose Pond Dam Improvements - Preliminary Design Concepts - Public Works Department

#### **RECOMMENDATION:**

Move that the Municipal Services, Facilities and Infrastructure Committee recommend that the City Manager be authorized to do all things necessary to implement the Goose Pond Dam Improvements Project, as presented.

#### **BACKGROUND:**

The City received a "Letter of Deficiency" (LOD) related to the Goose Pond Dam and Dike in June of 2015 from the New Hampshire Department of Environmental Services (NHDES) Dam Bureau. Several of the deficiencies were corrected using City personnel and equipment. Many of the deficiencies identified by the NHDES require detailed engineering investigation and design. In March, the City entered into a design contract with Dubois & King, Inc. of Randolph, VT, to complete preliminary and final design of improvements to address the remaining deficiencies.

Dubois & King has completed a topographic survey, field investigation, and preliminary design. Public Works and Parks and Recreation staff reviewed the design concepts and find them to be satisfactory.

Proposed improvements include:

- Widening the dam crest to 10 feet and installing a stability berm and filter on the downstream face.
- Replacing the existing gate valve within the outlet chamber.
- Lining the existing outlet pipe through the dam.
- Raising the dike approximately 2-feet to meet increased hydrologic and hydraulic requirements from the NHDES.
- Improving the access road to the dike.
- Excavating a construction staging area at the existing entrance to the site on Woods Drive.
