SUBJECT: Dog Warrant - City Clerk's Office

RECOMMENDATION:

That the City Council issue a warrant for unlicensed dogs pursuant to NHRSA 466:14, and the Animal Control Officer be directed to issue a civil forfeiture to those dog owners who have failed to license their dog by April 30, 2018.

BACKGROUND:

State Statute provides that the City Council authorize the yearly warrant for unlicensed dogs. The civil forfeiture carries a \$25.00 fine that must be paid by the dog owner within 15 days of receiving notice. Failure to license the dog and pay the civil forfeiture would result in a complaint being filed with Keene's Eighth Circuit Court. The following mechanisms for reminding dog owners of the licensing requirement were followed: 2 official publications appeared in The Keene Sentinel, monthly reminder emails sent to dog owners beginning in February, reminder postcards sent to owners with no email address in April, and in May an Office volunteer facilitated personal phone calls to owners with no email address on file. To-date, the City Clerk's Office has issued 2,311 dog licenses for the 2018 license period. This year the warrant contains 355 dog owners, with 437 dogs remaining unlicensed.

Dear Councilors:

After a preliminary meeting with Kurt Blomquist, Public Works Director, we are appealing to the City of Keene to partner in the installation of water and sewer lines at Ashuelot Court, designated as a private road.

As you may know, Ashuelot Court was part of the original Colony and Faulkner property and deeded by Emile Legere, Inc. to the Keene Housing Authority who subsequently conveyed the property to the City of Keene by deed dated September 17, 1971. It appears that the original water and sewer lines were installed by Colony and Faulkner. In 1993, Council was asked to take ownership of the water line and agreed to do so with partnering of the property owners providing \$8,000 of the cost. For unknown reasons, it appears that the property owners did not ultimately agree to this arrangement.

Presently, the sewer line of the property is compromised and needs to be replaced. Kurt Blomquist estimates that the main water line (2" vs. current standard of 6") was installed in the 1930's. It seems prudent and economical to replace both the sewer and water lines at the same time. A private contractor's estimate to install the sewer line is \$26,075.50 (copy attached). This estimate does not include simultaneously replacing the water line, which we estimate to add approximately 50% to the project, for a total cost of ~\$40,000.00.

There are four properties on Ashuelot Court. We propose that each property owner contribute \$2,500 to the project cost for a total contribution of \$10,000. If the Council agrees, ownership of the water and sewer lines would transfer to the City.

We appreciate your consideration of this proposal. Your approval will be greatly appreciated and help to resolve a long litany of concern and contention re. these issues amongst the homeowners and the City of Keene.

BACKGROUND:

Through the efforts of the arts community and championed by Councilor Carl Jacobs, the purpose of this resolution is to provide the City of Keene with an official way to establish Public Art within the city.

In April, a draft for public art guidelines was brought forward to the Municipal Services, Facilities & Infrastructure Committee (MSFI). As a result of that presentation, staff has brought forward a draft resolution for the City Council to consider for adoption. This resolution reflects how the City Council will consider public art projects through the basic standards of criteria along with a set of requirements and conditions.

As stated in the Comprehensive Master Plan (CMP) on pages 106 and 107, it is understood that “Public art demonstrates a community’s commitment to arts and culture, creating lively and attractive urban streetscapes and a unique sense of place.” In addition, the CMP suggests the creation of a community arts council. Although these types of councils exist with Arts Alive and the Friends of Public Art, the creation of a City commission to oversee the process would advance the initiatives of public art within our community.

The City of Keene has a vibrant downtown and quality parks; the addition of public art supports the vision set forth from the CMP and the direction provided by current art enthusiasts who have demonstrated the importance that public art can have on the City’s economic and cultural vitality.

Adoption process: The MSFI will recommend adoption of the draft resolution to City Council for review at the June 27, 2018 meeting. Should there be no alterations; a resolution will be brought forward to City Council on the July 5 meeting.

COUNCIL POLICY: RELATING TO THE ACCEPTANCE AND PLACEMENT OF PUBLIC ART

WHEREAS: Public Art plays an important role in increasing the understanding and enjoyment of art by the community. Art is more accessible and visible to people when displayed in public areas. A key feature of Public Art is the importance of integrating art into the fabric of the community in order to enrich and enhance the physical attractiveness of the community; transforms spaces and makes a valuable contribution to the appreciation of the community and the quality of public places.

WHEREAS: The City of Keene desires to participate in the promotion and display of Public Art to: Contribute to the unique identity of the City; enhance the City's economic and cultural vitality; and to encourage Public Art that is accessible to the public visually and physically.

NOW THEREFORE BE IT RESOLVED: Public Art may be located on public property in areas that are frequently visited, viewed or accessed by the public. Locations may include public right-of-ways, intersections, City parks, City owned property, and City owned buildings, and

BE IT FURTHER RESOLVED: Artist(s) and/or organization wanting to create, provide, or develop Public Art will submit a proposal to the City Council that provides sufficient information for the City Council to consider the proposal. When the City Council is considering Public Art, temporary or permanent, to be installed on, or in, property under the City ownership or control it may consider;

- Whether the project reflect aspects of the City's history, unique environment, cultural identity or community at-large,
- Whether the project aesthetically enhances the public space or built environment to which it relates or otherwise interacts with,
- Whether the project is designed for the proposed site and is commensurate in scale with its surroundings,
- Whether the project is technically feasible to produce and to display,
- Whether it is unique and original and not mass produced or standardized,
- Whether the project is durable (constructed of materials that will survive in the environment it will be placed) and reasonable to maintain in terms of time and expense,
- The experience of the artist(s) and/or organization in the production of the type of artwork and the provision of documents that demonstrate the artist(s) and/or

organization is recognized by critics and by his or her peers as one who produces works of art,

- Whether the Public Art is in a location that allows for necessary maintenance,
- Whether the Public Art is designed to be reasonably protected from environmental degradation, damage, vandalism, or theft,
- Whether the Public Art is affixed to a structure or building is the structure or building will remain in good condition for 20 years,
- Whether the project creates a public safety or security concern, and

BE IT FURTHER RESOLVED:

- Temporary Public Art is intended not to be owned by the City, remains in the care, control, and ownership of the artist and/or organization, can be easily installed and removed, intended to be displayed for a specific period of time and will be subject to a memorandum of understanding between the artist and/or organization that is acceptable to the City Council prior to display.
- Permanent Public Art is owned by the City, is attached to a structure, is of a size or construction that it cannot be easily removed, is under the control of the City and the artist(s) and/or organization shall give up all rights and control to the City.
- Public Art proposals will be in writing and shall include the following minimum information.
 - A description of the proposed public art including but not limited to: name of artist, partners or organizations involved, demonstration of the experience of the artist(s) and/or organization in the production of the type of artwork and the provision of documents that demonstrate the artist(s) and/or organization is recognized by critics and by his or her peers as one who produces works of art.
 - Whether it will be a temporary or permanent.
 - Identify the location.
 - A Description of the Public Art that includes size, expected amount of space to be required, materials to be used, theme or context, whether it is permanent or temporary, if temporary, length of time of the display, Identify how the project is designed for the proposed site and is commensurate in scale with its surroundings, drawings, design documents, how the project will be accessible to the public for viewing and enjoying, etc.
 - Whether if utility hookups are needed.
 - How the project being funded.
 - Identify the expected general maintenance requirements.
 - If temporary, identify how will the public art be removed, and the space restored.
 - Identify the materials and how the project is durable (where applicable) and what the expected maintenance and expense.

- How the project aesthetically enhances the public space or built environment to which it relates or otherwise interacts with its surroundings.
- Include assurances the art does not infringe upon the any copyright and agrees to hold the City harmless for any copyright infringement.
- A description on how the artist/organization will document the construction and installation of the Public Art and provide copies of this information in a format acceptable to the City.
- That the artist(s) and/or organization proposing Public Art is required to provide the necessary insurances and indemnification agreement during construction/installation and/or during display as determined by the City Council,
- If the Public Art is not owned by the City, the artist(s) and/or organization proposing the Public Art will be responsible for the expenses of monitoring, operation, maintenance, repair, and removal,
- The City shall have the right, at its sole discretion, to determine when or if it is necessary that Public Art is removed from public display.
- The City Council at its sole discretion to determine whether Public Art is accepted for ownership by the City,
- The City Manager is authorized to develop and administer rules and procedures to determine whether Public Art is acceptable for submission and approval; for the management, monitoring, installation, maintenance, repair, operation, and removal of Public Art, including requesting the City Council adopt City Ordinances as appropriate, and
- The City will establish an expendable trust for expenses associated with commissioning, installation, monitoring, maintenance, repair, operation, and removal of Public Art, and
- Public Art is to be owned by the City the donor shall contribute to the City a sum equal to 1% of the construction cost of the Public Art to be used by the City for the monitoring, operation, maintenance, repair, upkeep, relocation, removal or other actions or activates for the preservation of the Public Art.
