SUBJECT: Keene Lions Club - Request to Use City Property - 30th Annual Ashuelot River Duck Race - Public Works Department

RECOMMENDATION:

Move that the Planning, Licenses and Development Committee recommend to support the 30th Annual Great Ashuelot Duck Race and that the Keene Lions Club be granted a license to close the appropriate City street on June 29, 2019, and if necessary on another date, in coordination with City staff; the use of 350 Marlboro Street for counting and sorting ducks and a City front end loader to be coordinated with City Staff; and the provision of the appropriate insurance and indemnification to be coordinated by City Staff.

BACKGROUND:

The Keene Lions Club has submitted their annual request for the closure of a City Street to dump ducks into the Ashuelot River, use of 350 Marlboro Street for counting ducks and use of a City front end loader to dump the ducks. This will be the 30th time the Keene Lions have held this event. The Keene Lions have been evaluating the location for their duck race and have not finalized a location. The Lions Club has been working with City staff to determine the appropriate location to safely dump the ducks and for club members to retrieve the ducks from the Ashuelot River. Due to weather conditions, locations have not been able to be adequately located.

Staff is comfortable with continuing to work with the Keene Lions Club to determine the best location and recommend that the City Council grant permission to close the appropriate street.

Dear Honorable Mayor Lane and City Council Members:

We are applying to the City Council for a Lodging House License in order to provide space for an overflow for homeless people from the Hundred Nights Shelter. This letter will serve as our request for this license. We will have an inspection by the Keene Fire Department to ensure that we comply with the safety regulations, and are happy to welcome anyone to visit our Church.

We are providing this shelter on an overflow basis only, so it is not in operation every night nor throughout the year. We do not "let" rooms. We use a process by which people asking for shelter must check in at Hundred Nights, and comply with their procedures before being escorted to our church. Church volunteers are contacted by the Shelter in order to admit people to the overflow shelter in our downstairs meeting space. When it is in operation, we have an average of 6 to 9 guests, not including the two supervisors, one from Hundred Nights, and one a Church volunteer. There is always at least one person awake overnight.

We would like the license to allow for 10 people seeking shelter overnight plus the two supervisors in the church at any one time. The United Church of Christ in Keene asks for no money from the people using the shelter, from Hundred Nights, from the City, nor from any other person or organization. This Mission Outreach program is completely paid for by the Church and its members.

It is our understanding that there is a cost of \$165 associated with the Lodginghouse license.
