Municipal Services, Facilities and Infrastructure Committee report read recommending the City Manager and City staff be authorized to do all things necessary to negotiate and execute the necessary documentation with the Monadnock Food Co-op and Railroad Street Condominium Unit Owners Association for encroachments in the City's Drainage Easement located on the former Railroad Property subject to conditions identified by staff. A motion by Councilor Manwaring to carry out the intent of the report was duly seconded. The motion passed with a unanimous vote in favor.

#### CITY MANAGER COMMENTS

The City Manager announced there is free parking downtown through December 25<sup>th</sup>. She encourages the public to come downtown and shop local.

The City Manager advised there will be an informational communication distributed regarding the Marlboro Street Project and a public information session that will be held on January 15<sup>th</sup>. It will be an open-house format from 4:30 PM to 6:00 PM so the public can drop in and talk with the design team. There will be a brief presentation from 6:00 PM to 6:30 PM followed by a Q&A and a casual conversation at 7:30 PM.

The City Manager reported that in 2017, the Police Department logged 672 hours and for 2018, as of December 13th 848 hours were logged for foot patrol or bicycle patrol in the downtown area. This is a 26% increase from 2017.

The City Manager stated the City had not been successful in its application for a planning grant for the downtown project. The grant was a *Build America Grant* that was just over \$700,000. She added there were no planning grants selected anywhere in the United States. They were all construction grants. The Manager noted this was unfortunate since we were going to use the grant for preliminary designs for the downtown and then apply later for the construction grant. City Manager informed the Council that they will be having more conversations regarding the downtown project as they move into the Capital Improvement Plan.

# 2018 HOMELAND SECURITY GRANT PROGRAM AWARD – HAZMAT ALLOCATION – FIRE DEPARTMENT

A motion by Councilor Greenwald to suspend the Rules of Order to act upon the 2018 Homeland Security Grant Program Award – HazMat Allocation was duly seconded. On roll call vote with 14 Councilors present and voting in favor. Councilor Sapeta was absent. The Chair invited the Fire Department Chief, Mark Howard to come forward. Chief Howard informed that on October 14, 2018, the Fire Department was approved by the City Manager to apply for the 2018 State of New Hampshire Security Program Hazardous Materials Grant. The Chief reviewed the equipment details that would be funded through the grant. Chief Howard confirmed this was a grant the Department has received in the past. A motion by Councilor Greenwald recommending that the City Manager be authorized to do all things necessary to accept a grant in the amount of \$25,303.94 from the 2018 State of New Hampshire Homeland Security Grant Program was duly seconded. The motion passed with a unanimous vote in favor.



### **BACKGROUND:**

The Harris Center for Conservation Education is requesting the temporary closure of North Lincoln Street for a period of six weeks for the safety of the migrating amphibians and the families that come out to watch.

To the Honorable Mayor and City Council,

I am writing to once again request the temporary closure of a portion of North Lincoln Street for approximately 6 nights during a 6-week period in March and April, in order to ensure the safety of migrating amphibians and the many families who come out to watch them.

As you may remember, thousands of salamanders and frogs make their way to breeding wetlands – including the wetland adjacent to Woodland Cemetery and North Lincoln Street – on the first warm, rainy nights of spring, and many are killed when they must cross roads. Studies have shown that even modest vehicle traffic can have a significant negative impact on local amphibian populations.

Last spring, the Harris Center for Conservation Education worked with City staff to institute temporary detours around the North Lincoln Street amphibian crossing site on migration nights, facilitating the safe passage of more than 2,000 frogs and salamanders. On any given night, 20 to 50 people also visited the site to see the amphibians, including dozens of families with young children who'd never experienced a "Big Night" before.

Stories on the road closures appeared in the Keene Sentinel, Monadnock Ledger-Transcript, Concord Monitor, and New Hampshire Union Leader, and on NHPR. New Hampshire Chronicle also re-ran an older segment on our Salamander Crossing Brigades that was partially filmed at the North Lincoln Street amphibian crossing. The City's social media posts on the detours reached nearly 78,000 people — orders of magnitude higher than any of the Public Works Department's other posts — and the vast majority of comments were supportive.

In addition, I presented on the amphibian detours at the Northeast Partners in Amphibian and Reptile Conservation annual meeting (August 2018) and the Northeastern Transportation and Wildlife Conference (September 2018). In both instances, the City was commended for their collaboration with the Harris Center on this project.

Closing this section of road on migration nights in the spring of 2019 would once again ensure the safety of thousands of animals — which are an important part of the Robin Hood Park

ecosystem – and scores of people who come to North Lincoln Street to observe the spectacle. The planned detour will not impact anyone wishing to travel to their home on North Lincoln Street, as the closure spans the section of road bounded to the east by Robin Hood Park and to the west by Woodland Cemetery.

As a reminder, the amphibian migration is a weather-dependent phenomenon, so I cannot provide specific dates for the requested road closures at this time. However, last spring we worked successfully with the Department of Public Works and the Parks, Recreation, and Cemetery Department to implement the road closures and to inform the public about them. We anticipate a similarly smooth road closure and notification process in 2019.

I've spoken with Duncan Watson, Assistant Public Works Director, who affirmed that the closures represent a minor impact in terms of labor and resources dedicated to installing the detour. According to Duncan, "the Public Works Department is pleased to join in the enthusiastic public support for this important project."

Thank you for your consideration of this request, which would benefit both wildlife and people in Keene. I would be more than happy to meet with you, or to make a brief presentation to whichever subcommittee is assigned this request, to provide more information and to answer any questions you have.

We are applying to the City Council for a Lodging House License in order to provide space for an overflow for homeless people from the Hundred Nights Shelter. This letter will serve as our request for this license. We will have an inspection by the Keene Fire Department to ensure that we comply with the safety regulations, and are happy to welcome anyone to visit our Church.

We are providing this shelter on an overflow basis only, so it is not in operation every night nor throughout the year. We do not "let" rooms. We use a process by which people asking for shelter must check in at Hundred Nights, and comply with their procedures before being escorted to our church. Church volunteers are contacted by the Shelter in order to admit people to the overflow shelter in our downstairs meeting space. When it is in operation, we have an average of 6 to 9 guests, not including the two supervisors, one from Hundred Nights, and one a Church volunteer. There is always at least one person awake overnight.

We would like the license to allow for 10 people seeking shelter overnight plus the two supervisors in the church at any one time. The United Church of Christ in Keene asks for no money from the people using the shelter, from Hundred Nights, from the City, nor from any other person or organization. This Mission Outreach program is completely paid for by the Church and its members.

It is our understanding that there is a cost of \$165 associated with the Lodginghouse license.
