Approval of Minutes

Ms. Newcombe made a motion to approve the minutes of the January 2020 meeting as presented, Ms. Snow seconded. Motion carried unanimously.

Asheulot River Park Budget 2019

Ms. Gray presented the 2020 budget prepared by Andy Bohannon, Parks, Recreation & Facilities Director and previously adopted by the Ashuelot River Park Advisory Board in the amount of \$23,000.00. Ms. Gray stated that unfortunately Mr. Bohannon was away and unable to attend but would be happy to answer any questions at a later date, if necessary. In addition to the regular budget items of \$10,500.00 (landscape contract, pruning and a small amount for miscellaneous items), the request includes \$12,500.00 for the Conway School of Landscape Design to create a master plan for the park. The request is to utilize the balance in the #528 Ashuelot River Park Memorial Trust, approximately \$5,813, for partially funding the Conway School contract with the balance of the Conway School contract and other budget items, approximately \$17,187, to come from the interest in the #529 Ashuelot River Park Trust.

Ms. Snow made a motion to approve the 2020 budget of \$23,000.00 as presented, Ms. Newcombe seconded. Ms. Silver recused. Motion carried 4-0.

Maurice Alger Scholarship

Mrs. Gray reported that she has been contacted by Keene High School regarding the annual award for the educational scholarships. Mrs. Gray stated that the Alger scholarship is awarded yearly. After Trustee discussion and review of the current income balance, Ms. Gemmell made a motion to award the Maurice Alger Scholarship for \$7,000.00, Ms. Snow seconded. Motion carried unanimously.

Frank Wright Scholarship

As previously requested by the Trustees, Mrs. Gray reviewed an analysis of the current and projected income in the Frank Wright Scholarship. The Frank Wright scholarship has historically been awarded every four years and was awarded in 2019 for four years @ \$20,000.00 per year. The scholarship allows for awards to be made when there is sufficient income available to support an award, and the Trustees were considering whether there was enough income for another scholarship in 2020. Mr. Forrest was concerned that there was not currently enough actual income to support a new scholarship and with current market conditions perhaps this could be re-visited next year. After further discussion, the Trustees agreed and asked Ms. Gray to add this to the future items in February 2021.

The Trustees, acting as the Review Committee, were asked to review and score the proposals and return the review sheets to Ms. Gray by Friday, March 6, 2020. Ms. Gray will then consolidate the scores for the next meeting of the RFP Review Committee on March 18, 2020.

BACKGROUND:

Asst. Finance Director Merri Howe addressed the Committee next. Ms. Howe stated this item was read at the September 2017 meeting of the City Council and referred back to the FOP. She explained there is a 1.8 million cash flow for the library project.

The partners of this project, MEDC, the Library Trustees and the Friends of the Library attempted to secure a bridge loan for this project but were unsuccessful. This Resolution will provide the 1.8 million in funding through the General Fund assigned fund balance ending realization of pledges.

Ms. Howe stated there are some risks – the pledges that come in will be applied on a monthly basis which will reduce the amount owed. There are pledges in the amount of about 79% scheduled to come in between September 2017 through May 2018 and anything additional will be applied against the balance.

Councilor Clark asked what percentage of pledges won't be collected.

Ms. Judy Putnam Co-Chair of the Capital Campaign stated they have been receiving money for two years and so far no one has missed a payment. They continue to get new pledges and felt the risk is low. Chair Greenwald clarified they have a plan for non-collectable pledges. Ms. Putnam stated they will keep raising the money.

Councilor Jacobs asked for the reason the bridge loan was not successful. Ms. Putnam stated it is because the Attorney General did not permit the use of pledges as collateral. Councilor Powers stated he has no reservation providing this money because of the names on the list who have provided these pledges and felt if something comes up short they would take care of it.

Councilor Jacobs made the following motion which was seconded by Councilor Chadbourne.

On 5-0 vote, the Finance, Organization and Personnel Committee recommends the adoption of Resolution R-2017-31: Related to an Appropriated for the Library Campus Development Project.

Schedule A

LIBRARY RENOVATION TRUST FUND

- I. <u>Creation and Administration</u>. There is hereby created a City temporarily restricted trust fund to be held and administered by the Trustees of Trust Funds and Cemetery Trustees (the "Trustees") to be known as the Library Renovation Trust Fund (the "Fund"). The City of Keene on behalf of the Fund shall accept all irrevocable bequests, contributions, cash, and other gifts, payable on demand in United States currency or marketable securities to the Fund. All funds so received shall be used as set forth herein by the Trustees, or as nearly so as they can determine to be practicable in order to carry out the intent of the Fund as described herein.
- II. Application of Principal and Interest. The principal of the Fund, and any accrued interest or income thereon, shall be applied toward the costs and expenses for the renovation and expansion of the Keene Public Library located at 60 Winter Street, and including but not limited to, the renovation of the Library Annex located at 76 Winter Street, which is to be attached to and included in the Keene Public Library and surrounding library campus and as generally described on the attached diagram (collectively "Library Project"); provided, however, that if the Fund, together with any other funds that may be raised for the Library Project outside of the Fund, are insufficient to complete the Library Project as intended, then the Fund may be expended as stated in Article III, below. The Trustees shall invest all funds received by the Fund as they are authorized to do by law, until expenditures from the Fund are requested by the City of Keene for the public purposes stated herein; provided; however, that the authority for any expenditures from the fund shall rest solely with the Trustees, which authority may include expenditures from time to time, or a lump sum distribution of the Fund depending on the needs of the Library Project.
- III. <u>Excess Principal.</u> In the event that there is principal and accumulated interest or income in the Fund in excess of the amount necessary for the Library Project, or in the event that the Library Project cannot be completed as originally intended for any reason as determined by the City, then the Trustees shall transfer the Fund, together with accumulated interest or income, to the Library Trustees.
- IV. <u>Cessation of the Fund</u>. The Fund shall cease to exist at any time after the completion of the Library Project as described herein and as determined by the City Building Inspector, or at such time that the principal and accumulated interest or income of the Fund equals zero, but in no event later than December 31, 2025.
