SUBJECT: Laboratory Renovation Design Engineering Change Order - WWTP Operations Manager

RECOMMENDATION:

Move that the Finance, Organization, and Personnel committee recommend the City Manager be authorized to do all things necessary to negotiate and execute Change Order 1 with Underwood Engineers for engineering and technical services for upgrades to the existing heating and ventilation system in the Laboratory for an amount not to exceed \$4,400 for contract 04-21-22.

BACKGROUND:

The Wastewater Treatment Plant (WWTP) came online in 1985 and treats approximately 3 million gallons of wastewater every day. The Laboratory Division of Public Works is located at the WWTP and is responsible for analyzing compliance and process control samples for both wastewater and drinking water.

The laboratory itself is vintage, mid-1980's, with minimal changes occurring to the interior since the plant was built. The laboratory has continued to keep up with industry standards with regards to its analytical equipment, but the cabinets, benches, and shelving are original to the plant and have reached the end of their useful life.

As part of the Capital Improvement Program (CIP) the City has a project to renovate the Laboratory. Change Order 1 is to address needed modifications to the existing heating and ventilation system, this work was not included in the original design contract. In the original scope of services, it was not anticipated that the heating and ventilation system would need to be addressed. During the preliminary review of the laboratory, it was found that the existing heating and ventilation does not meet current health and safety codes. Since the laboratory is having substantial work being accomplished the heating and ventilation system needs to be brought into health and safety code compliance.

The scope of the additional engineering services includes the following:

- Address deficiencies with the laboratory fume hood make up air system,
- Design relocation of air intake, and
- Design system to comply with current building code requirements.

The cost of the change order exceeds the City Manager's 10% authority staff recommends the City Manager be authorized to do all things necessary to sign a change order with Underwood Engineers for an amount not to

exceed \$4,400.	Funds for this work are available in the Laboratory Renovation Project 08106-64102 budget.

SUBJECT: Acceptance of Local Source Water Protection Grant - WWTP Operations Manager

RECOMMENDATION:

Move that the Finance, Organization, and Personnel committee recommend the City Manager be authorized to do all things necessary to accept and execute a Local Source Water Protection grant from the New Hampshire Department of Environmental Services (NHDES) in the amount of \$8,500 for the installation of security fencing at Babbidge Reservoir.

BACKGROUND:

The City of Keene has received and will use the NHDES Local Source Water Protection grant funds to construct a security fence to restrict and deter unauthorized access to its surface water reservoir. NHDES approved Keene's application for \$8,500 grant funds to install 400 feet of fence around portions of Babbidge Reservoir to enhance security and the protection of water quality. The grant award is conditioned on:

- Acceptance by Keene's City Council,
- Adherence to New Hampshire purchasing requirements, and
- Share photos of completed fence with NHDES

Expenses for City of Keene staff to clear trees and vegetation prior to installation of the fence are not covered by the grant, but will be funded from the Water Treatment Facilities Operating Budget. The total estimated labor cost for this is \$3,356.64.



BACKGROUND:

The Monadnock Alliance for Sustainable Transportation (MAST) has been the curator and distributor of funds allocated to various Southwestern New Hampshire projects. In collaboration with the Cheshire Health Network, MAST has requested the Monadnock Regional Rail Trail Collaborative to submit an application for a project involving the City of Keene and the Towns of Swanzey and Winchester. The purpose of this project is to create uniform signage along the rail trails for users to understand where they are located along the trail. The grant total is \$19,048.00 and the City portion of the total funding is \$4075.00.


The City is currently conducting a pilot project through MAST for the interior trail network within the City's downtown area. The signage for this new request will be placed on the outer edges of the trail providing location and mileage markers for users to know their location on the trail system. More importantly as the region's trails system become improved, a consistent identification of signage will be located on the many miles of trails.



Dear Ms. Zahn,

The City of Keene, the Town of Swazney, and the Town of Winchester, as part of the Monadnock Region Rail Trail Collaborative regional rail trail reconstruction plan are submitting for the MAST grant to cover the cost of rail trail signs, kiosks, and vistas. These signs, kiosk, and vistas will cover the Cheshire Rail Trail and Ashuelot Rail Trail in Keene, Swanzey, and Winchester, a total of 29 miles of rail trail. The sign types are wayfinding (trail/road crossing, trail/trail crossing), town line, and prohibitive vehicle. An example of each sign type, kiosk, and vista are included with this letter. The signs are designed in a fashioin that allows easy expansion of the same branding across the Monadnock region rail trail network. Here are the particulars by municipality:






