Subject: Acceptance of Donation and Update on Skate Park Project - Parks,

Recreation and Facilities

Recommendation:

Move that the Finance, Organization and Personnel Committee recommend that the City Manager be authorized to do all things necessary to accept a donation of \$200,000.00 for the purpose of building a new skate park.

Background:

In 1996, the skate park in downtown Keene was one of the first of its kind in the area. The park was spearheaded by volunteers who put forth a large fundraising effort and then donated the final project back to the City of Keene. Carefully researched and designed, the skate park was a great new asset for the community.

In 2009, Mayor Pregent created a re-location committee to kick start the conversation about building a new skate park. The committee put together an in-depth report on the value of a skate park in Keene and delivered it to City Council in 2011. The report included skate park locations, Gilbo Avenue being one, and the size requirement needed to successfully serve the skating community. After the initial report, another group came forward in 2015 to hire a consultant and design a skate park to be located in Wheelock Park; however, the cost of the facility and the groups' fundraising ability quickly slowed progress on the project.

In 2018, Kathleen Burke and the mom of BMX rider Sean Zimmerman, came forward with the goal of raising funds to build a new skate park. Ms. Burke was organized, willing to make "the ask" for donations and made all the right connections. She quickly formed a group called the Keene Skatepark, who created a website and established a social media presence. After an online giving portal was created and donors were contacted, they raised \$200,000 towards a \$300,000 goal. Unfortunately, the COVID-19 pandemic hit and halted the energy into fundraising and building of the park; however, with Pathways for Keene as the Fiscal Agent for the Keene Skatepark group, the project continued to succeed with fundraising through online platforms.

In the Capital Improvement Program, a \$25,000 commitment has been made by the City of Keene, in addition, Ms. Burke has again gone above and beyond and is pursuing a few larger pledges, to reach a revised goal of \$250,000.00.

The skate park on Gilbo Avenue is 9800 square feet and the new park would remain within that existing footprint. The current park structures are made of wood and GatorSkins with steel transition plates. As a result of the park's age, the NH winters have made repairs difficult and, in some cases, pieces have had to be removed. The new park would be a poured in place concrete facility.

Upon acceptance of the donation, the City will begin, through the Purchasing Department, an RFP process for a design build park. There will be a group of dedicated skaters, along with City staff who have been involved with the project, to help select the right firm.

The Keene Skatepark group will continue to fundraise to make the location and destination for the local skate enthusiast a reality. A progress report will be provided to the Council related to the design build schedule of the project.

The forfeited money in question was seized in conjunction with drug investigations conducted jointly by Keene PD and U.S. Homeland Security Investigations and is broken down into two amounts. The first, \$4,244.44 was a result of an investigation that took place in the months of March and April of 2021. The second, \$28,855.79, is from an investigation that began in October of 2019 and culminated in June of 2020.

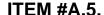

Background:

Mr. Kevin Provost of Monadnock Choppers has expressed interest in leasing additional land at the airport to construct a 50'x60' steel aircraft hangar. This hangar would be used primarily for aircraft storage and for expanding his business at the airport.

The construction of new hangars benefit the airport and the City of Keene by providing additional revenue to the airport through the lease and to existing airport businesses through increased aeronautical activity at the airport.

Negotiations for this lease would follow the Airport Land Leasing Policy.

Background:

The Airport Rescue Plan Act includes funds made available by the Federal Aviation Administration as economic relief to eligible U.S. airports affected by COVID-19 pandemic for the prevention of, preparation for, and response to pandemic.

As the Keene Dillant-Hopkins Airport is eligible for funding from this program, we have applied for and anticipate a grant offer for \$59,000 and we are requesting that the City Manager be authorized to do all things necessary to accept and execute this grant, which will be awarded through the New Hampshire DOT.



Background:

Konstantinos and Demitris Georgiadis are currently contracted to lease space at 12 Gilbo Avenue for the purposes of a frozen yogurt shop. The owners would like to make some minor improvements to the operations and requests an extended contract, thus ensuring their long-term investment. The lessees are currently in the second year of a 2.5 year (30 months) lease, with an option for one additional year (12 months). They are seeking a new agreement for a three year lease with an additional three year option.

The contract terms and fees were recently negotiated in 2020, and the hope is to retain the current structure.

Additionally, the frozen yogurt shop is in an ideal location within the downtown area and along the Cheshire Rail Trail. Through the City's efforts to better understand the economic impact of the trail system on the downtown business, the UNH Cooperative Extension is completing a survey. This survey will only benefit the current tenant and other surrounding downtown businesses.

Background:

The New Hampshire Department of Justice has indicated its intention to join a proposed nationwide settlement agreement that would resolve all opioid litigation brought by states and local political subdivisions against the three largest pharmaceutical distributors, McKesson, Cardinal Health and Amerisource Bergen. As part of the settlement process, the Attorney General sent notices to New Hampshire subdivisions that have filed their own opioid lawsuits against these defendants. The City of Keene has been engaged in its own opioid litigation since 2018. Participation is encouraged as the extent of participation determines the amount of money each state and its subdivisions would receive. You may find detailed information about the settlement at:

Background:

The Wastewater Treatment Plant (WWTP) came online in 1985 and treats approximately 3 million gallons of wastewater every day. The Laboratory Division of Public Works is located at the WWTP and is responsible for analyzing both wastewater and drinking water compliance and process control samples.

The Laboratory itself is vintage, early 1980's, with minimal changes occurring to the interior since the plant was built. The Laboratory has continued to keep up with industry standards with regards to its analytical equipment, but the cabinets, benches, shelving and portions of the HVAC are original to the plant and have reached the end of their useful life.

As part of the Capital Improvement Program (CIP) the City has a project to renovate the existing Laboratory. The design is complete and bids for construction services were received on September 27, 2021. The City received one bid for \$202,450. The City's total project budget was \$143,000 which included both engineering and construction services. To date \$37,700 has been expended on engineering services, leaving a project balance of \$105,300.

Increased engineering costs associated with building code required upgrades to the HVAC system, as well as increased steel and labor costs account for the majority of the overages. Staff is requesting \$117,150, which includes a \$20,000 contingency, from the WWTP Capital Reserve Fund Balance be allocated to the WWTP Laboratory Renovation Project 08106.

Background:

The City's Wastewater Treatment Plant is permitted by the Environmental Protection Agency (EPA) to discharge treated wastewater into the Ashuelot River. The City's current NPDES permit expired in 2012.

The City, through the CIP process, funded a project for legal and permitting assistance. The City executed a contract with Weston and Sampson Engineers in 2016 to assist with the permitting process and Drummond & Woodsum Attorneys at Law have been providing legal services.

On May 20, 2020, the City received its draft NPDES permit and responded to EPA with comments. In September 2021, the City received its final permit and determined that there is a need to appeal and negotiate various requirements.

Due to ongoing negotiations, extra funds are needed for technical support, engineering studies and

legal assistance. Previous funding through the CIP process and operating budget carryover requests are no longer available.

Weston and Sampson have provided a scope of work to perform technical evaluations for aluminum and pH, as well as continued technical support and engineering services for approximately \$115K. The remaining \$25K will be used for any legal services needed to negotiate and complete the permitting process.

Staff is recommending that \$140,000 for this work come from the Sewer Fund Unassigned Fund Balance and be appropriated to the Wastewater Treatment Plant's NPDES Permitting Assistance Project (08012).
