Dear Secretary Scanlan:

There is a slight discrepancy in the number of names marked off on the Ward Five voter checklist as having cast a ballot as compared to the number of ballots cast at the Nov. 8th State General election. I wanted to include in our submission of the Moderator's Worksheet, an explanation of what we did to reconcile this discrepancy and our best guess as to what happened.

The Accuvote tabulator tape indicates that 2203 ballots were accepted and read by the tabulator. In addition, 31 ballots were hand-counted. This means that 2234 ballots were cast in Ward Five. The checklist from that election reflects 2236 voters as having voted. There is a discrepancy of 2 more voters than cast ballots.

We investigated whether any voters were mistakenly shown on the addendum checklist of same-day registration voters as well as the marked check-in checklist. No duplicate names were identified. We also checked whether any name changes or party changes were mistakenly added to the addendum checklist and we were able to verify that the addendum checklist only contains the names of those voters who registered and cast ballots on Election Day. We also spoke with the Moderator of that ward who contacted all workers who were assigned to the check-in checklist and none can recall a situation where a voter was mistakenly checked in.

Having taken these steps, our conclusion is that the Ward Five checklist *mistakenly* shows two voters having checked in to vote in this ward.
