Background:

Youth Services has been granted a funding opportunity from the State of New Hampshire totaling \$32,808 but disbursed in \$16,404 increments over the course of two State fiscal years.

The grant is specifically designated towards Juvenile Court Diversion programming. It will serve several purposes. First, it will provide assistance with restitution, provided the youth meaningfully participates in community service activities to "pay back" the assistance. This will relieve a portion of the financial burden many families face when their youth commit offenses.

This funding will also be used to provide community engagement opportunities such as documentary screenings, panel discussions, workshops, and guest speakers who can educate the community on the current needs of our youth. Furthermore, it will assist in purchasing films, displays and dioramas to assist in educating youth who are more "visual" learners. Funding will also be used to update office equipment, purchase office supplies, hire a paid intern and increase both the travel reimbursement and training budgets.

Recommendation:

The Finance, Organization, and Personnel Committee refer the attached recommended list of properties that are eligible for tax deed for unpaid 2018 property taxes to the City Council.

Background:

The tax collector must execute the deed for unpaid property taxes unless the City Council directs the collector to waive that process. A waiver is appropriate in certain circumstances that include:

- Taking deed to the property would subject the City to potential liability that might result from an environmental impairment of the property in question.
- Taking deed to the property would expose the City to undesirable obligations or liability risks, including obligations under real estate covenants or obligations to tenants;or
- Taking deed to the property would for any other reason, be contrary to the public interest.

The Deed Waiver will authorize the City Manager to sign deed waivers on the properties that are listed providing additional time for payment of the taxes, interest and costs outstanding. This action would extend the deadline for payment of the outstanding taxes. Following this deadline, staff will review the status of any accounts with outstanding 2018 property taxes and advance additional recommendations.

The recommendation for deeding will authorize the Revenue Collector to deed the two listed properties. The properties for deeding do not have payment plans or have broken the plans, and after several notices, phone calls, and emails, have not shown that the taxes will be paid.

There are three additional properties that are in bankruptcy and cannot be deeded.

For the following properties, city staff is recommending a waiver to tax deeding and will return after March 31, 2022 with additional recommendations after a review of the status of the accounts.
