Background:

On December 26, 2023, the Keene Police Department was notified that it was being awarded up to \$64,673.50 for the purpose of purchasing new Mobile Data Terminals and E-crash equipment for its patrol fleet. This grant is a matching grant with the city responsible for 25 percent of the equipment costs.

Our current MDT's were already budgeted to be replaced prior to being awarded this grant. Our 25 percent commitment to satisfy the grant falls within this budgeted amount and will allow us to also replace our current docking stations, printers and mounting hardware in addition to the MDT's. We have several docks and mounts that are worn and near end of life that need to be replaced.

Background:

The Department of Business and Economic Affairs introduced the InvestNH program in 2022. The program had multiple funding opportunities including a program to award communities that worked with property owners willing to develop affordable and workforce housing as part of larger projects. The housing development at 310 Marlboro is an innovative plan to put housing above a former factory building, now in use as a mixed-use development.

The Per-unit program allows the city to apply for \$10,000 per affordable or workforce housing unit proposed for a site. The Conservation Commission is recommending several measures that would ensure that street trees are cared for as vital parts of the City's natural infrastructure.


Dear Mayor Hansel and City Councilors,

As is our duty as Keene's Conservation Commission, we voted unanimously at our November meeting to urge you to take the following actions to address the current and future state of the city's street trees:

1. Conduct or commission an inventory and assessment of street trees within the public right of way.
2. Allocate additional funding to the city's existing street tree replacement program.
3. Establish a program for cost-sharing of new street trees with residential property owners, using a model similar to programs in Manchester or Nashua.
4. Develop a plan to manage the succession of aging stands of white and red pine planted throughout the city following the 1938 hurricane.
5. Fund and prioritize protecting and maintaining existing, high-risk, native street trees.

Keene's street trees create a cleaner, cooler, more beautiful city for all of its citizens and visitors and we urge you to care for and invest in these vital parts of the city's natural infrastructure. Should you require any further assistance in this matter, please do not hesitate to contact us.

Subject: **Cemetery Master Plan - Parks, Recreation and Facilities Director**

Move that the Finance, Organizational and Personnel Committee authorize the expenditure of up to \$65,000 in the Cemetery Trust Fund B – Capital Reserves for a professional services contract to create a Master Plan for Monadnock View Cemetery.

Background:

The City of Keene has maximized the space allocation in our current cemeteries except for Monadnock View. The cemetery currently has seven (7) open acres in the front and an additional one and a half (1.5) acres in the rear portion of the lot. In order to efficiently create space for the future of Keene, a well laid out design for future expansion includes land needs for short- and long-term demand, various demographic and trends analysis, site analysis, Bylaw and Rules Review, and a cost estimate for the future implementation.

Funds for this project are being utilized by the Cemetery Trust Fund B – Capital Reserve. The purpose of this Trust shall be a capital reserve fund to be utilized by the Cemetery Trustees from time to time for capital improvements to and enlargements of the public cemeteries of the City.

As of December 31, 2023, the current principle is \$1,343,495.57 and income is \$200,872.24. The fund was created in 1986 through Ordinance O-85-11A which states that the funds derived from the sale of lots will be split 50/50 between Monadnock Cemetery Trust Fund A and B.

On March 15, 2023, the Trustees of Trust Funds approved the expenditure for the purpose of creating a master plan at Monadnock View Cemetery. Should the FOP Committee approve this opportunity, it begins the process towards the Request for Proposals. As a result of the needed approval process, the design firm will not be selected until later this spring, upon which time a final approval will be needed by the Council on the contract associated with the master plan.
