Ms. Fortson stated that in order for the updated Rules of Procedure to become official, they need a quorum of members who are physically here to sign the printed copy of the Rules of Procedure at the end of the meeting. She continued that she will then file the document with the City Clerk's Office.

4) NH Saves Button-Up Weatherization Workshop

Vice Chair Roth stated that the NH Saves Button-Up Weatherization Workshop will be November 6th at 6:00 PM, with the location to be determined.

Ms. Koning stated that the Clean Energy Team put this together, and it is scheduled to be at the Parks & Rec Center. She continued that she hopes the ECC will co-sponsor the workshop, which would mean the use of the room at the Recreation Center would be free. The Clean Energy Team does not have a budget. The workshop will be open to the public, and the Clean Energy Team will do all the advertising. If the ECC co-sponsors, the advertising can include the ECC's logo.

Discussion ensued. Mr. Murphy spoke of how the workshop aligns with the ECC's purview. Ms. Maxfield stated that the ECC has co-sponsored this event in the past.

Ms. Maxfield made a motion for the Energy and Climate Committee to co-sponsor the NH Saves Button-Up Weatherization Workshop. Councilor Lake seconded the motion.

Councilor Lake asked for a quick overview of the workshop, for the sake of the minutes. Ms. Koning stated that NH Saves will come and explain energy cost savings and talk about insulation, windows, and heat and energy efficiency. She continued that it is well done and informative. They bring in samples of different kinds of insulation. They talk about cost savings and how to join the program by going to the website and putting in your information. It is helpful. The ECC sponsored a workshop like this last year. It was not very well attended, so they hope to do a better job with advertising this time.

Mr. Leversee stated that its what he remembers from last year, too, and noted that it would be good to have more people this time. He continued by stating that he thinks it would be appropriate for the ECC's Outreach Work group to coordinate with Ms. Koning on a plan for getting the word out. Ms. Koning agreed. Vice Chair Roth stated that (it is relevant to) the Resilience Work group, too.

The motion passed with a unanimous, roll call vote.

5) Eversource Main Streets Event – Next Steps

Vice Chair Roth stated that the meeting minutes say that Eversource was going to give (the City) a timeline for their Main Streets event.

 ECC Meeting Minutes July 23, 2025

Ms. Fortson stated that she spoke with Eversource earlier this week, and they hope to come to Keene the week of September 8th to 12th. She asked if anyone is aware of any events happening that week or the weekend before or after that. Discussion ensued.

 Ms. Fortson clarified that Eversource's event will be just during the business days, not the weekend. Vice Chair Roth replied that the ECC had suggested Eversource approach businesses that have downtimes on weekends. He continued that he does not know if they have pursued anything with the Greater Monadnock Collaborative (former Chamber of Commerce).

Discussion ensued about marketing. Ms. Fortson stated that Eversource has the promotional materials ready, but they want to nail down a date. Mr. Redfern asked if Eversource specified what they would be doing with this event. Ms. Fortson replied that Eversource gave a presentation at last month's ECC meeting and explained that they would be coming to Keene and approaching businesses about doing energy audits and giving recommendations to businesses for structural changes they could make to increase energy efficiency. If businesses do the work through the Eversource program, which she is done in conjunction with NH Saves, they can get lower cost work done by using the partner contractors. They wanted feedback from the ECC. Now they want feedback from the ECC on the proposed date.

 Peter Hansel, guest, stated that he wanted to give feedback on the last time they had this Eversource Main Streets event. He continued that it was a great success. Many businesses participated and many went on to take advantage of the discounts.

Vice Chair Roth asked if they have received feedback from Manchester regarding how the project went for them in May. Ms. Fortson replied no, they have not provided her with that information. Discussion continued, and Vice Chair Roth shared more information from the conversation at last month's meeting. Mr. Murphy stated that at the June ECC meeting, they discussed this at length – ideas, marketing, and who to work with - and he thinks now this is on today's agenda just to see if ECC members see any conflicts with the September 8th week that Eversource is targeting. He thinks it is a fine week.

Discussion continued, and others agreed that September 8th is a fine week, as long as Eversource has enough time to market the program before then. Ms. Fortson replied that Eversource has a specific timeline they follow for advertising these events. The group agreed that the week of September 8th is good.

Ms. Fortson stated that in preparation for the next meeting she can get some sample materials from Eversource, of what they will be sending out.

6) Annual Report to City Council

Vice Chair Roth stated that Chair Swymer signed the annual report to the City Council. Ms. Fortson replied yes, and that is (all for this agenda item) – she just wanted the ECC to be aware of it. She continued that the letter is in the agenda packet. Vice Chair Roth asked if anyone had questions or comments.

7) Hazard Mitigation Plan Updates

Ms. Fortson stated that Mr. Murphy had asked for an update on the FEMA maps and the Hazard Mitigation Plan. She continued that there is not an update on the FEMA maps, because that is up to the federal government, but she reached out to Kürt Blomquist, Emergency Management Director, who said they completed their final draft (of the Hazard Mitigation Plan). The Planning, Licenses, and Development Committee reviewed it on June 11th, and the City Council adopted it on June 19th. Now they are doing a final clean up and will submit it to FEMA and HSEM for review and approval, hopefully by the end of this month.

Mr. Murphy thanked Ms. Fortson and stated that he brought it up because he sees a lot of alignment between that work and the work of the ECC, so it is good for the ECC to understand what is happening. He continued that it sounds like good progress has been made. Discussion ensued, and members noted that the City's work on this is done, and they are waiting on the federal government. Mr. Murphy noted that the Hazard Mitigation Plan requires updating every five years, to stay copacetic with State and Federal guidelines and be eligible for potential funding.

8) Clean Energy New Hampshire Municipal Membership Benefits

Frank Richter from Clean Energy New Hampshire stated that Keene is a municipal member of Clean Energy NH, which is a nonprofit organization in Concord that helps small businesses and municipalities. He continued that the City of Keene pays \$300 a year for a basic membership, which comes with certain benefits. Members of municipal committees can register on Clean Energy NH's website and create a profile, and access all the benefits they offer municipalities. Mr. Richter spoke about the benefits they provide to municipalities, such as local policy tips; cohort trainings on topics such as EV charging and energy audits; a policy newsletter and invitations to the policy calls; policy webinars; and two complimentary tickets to the Local Energy Solutions (LES) conference in Manchester. If anyone has questions, they can let him know.

Ms. Maxfield asked for more information about the municipal membership benefit of "neutral expertise, technical assistance, and training for energy project execution," which looks interesting. Mr. Richter replied that if a municipality or school is applying for a grant to do solar projects or energy retrofits of buildings, that is something he helps a lot of towns with. He noted that he also helps customers with navigating direct pay, which is a tax credit municipalities can get for projects. Clean Energy NH can also offer advice if municipalities have questions about doing energy audits, or are seeking something like a list of reputable auditors or reputable installers for solar or EV charging, and they have people who track policies, funding sources, and legislation. Keene's Zoning is in a good position, but if things change, then Clean Energy NH can help.

Mr. Richter stated that an issue coming up in a lot of towns is that they want to put an EV charging station in, but it is treated as a fueling station, so they are changing the Zoning to accommodate that. Clean Energy NH is helping a couple of towns with their master plans to put energy efficiency language in place. Mr. Richter continued that Clean Energy NH also works with small businesses and farms. He spoke more about that work.

Ms. Maxfield stated that she has a follow-up question. She asked if "Energy benchmarking with a Portfolio Manager" means Clean Energy NH would help talk them through the process and find a company that would come and do an audit and installation. Mr. Richter replied yes, Clean Energy NH could help introduce them to an energy auditor to at least have a conversation with them. He continued that Clean Energy NH can connect them with certain energy auditors specializing in municipal facilities. They work closely with NH Saves. Clean Energy NH has a list of names to get proposals from or answers to questions.

Mr. Redfern stated that regarding the difference between the minimum membership benefits and the \$500-level benefits, he wonders how long the City of Keene has been at the \$300 level. Ms. Fortson replied that she is not sure, and she is not sure how long the City has had a membership with Clean Energy NH. She could find out. Mr. Redfern replied that he would like to know if the City has ever considered going to the \$500 level due to the potential benefits, such as additional tickets to the LES conference. Discussion ensued.

 Councilor Lake stated that the City discussed it a year or two ago and decided they did not need the additional tickets. He continued that they could discuss it again. Ms. Maxfield asked how much a ticket to the LES Conference costs. Mr. Richter replied that he can find out and let them know. Discussion continued about the tickets. Ms. Fortson spoke about how the ECC voted last year to use the ECC budget to purchase two tickets to the conference, and they could consider purchasing additional tickets to this year's conference as well, if there are members who are interested in going. Mr. Richter stated that he just looked up the answer to Mr. Redfern's question, and the City has had a membership since 2019, and it has always been at the \$300 level.

Vice Chair Roth stated that Mr. Richter said he works with Zoning for small towns. He asked if he works with Planning Boards for small towns, too. Mr. Richter replied yes, he has met with several Planning Boards. He continued that they recently did a cohort training with 35 towns, a three-month training basically to do what the City of Keene did with permitting and solar-friendly zoning. He walks Planning Boards through this process. Discussion ensued about the Monadnock Resource Alliance, and Planning Boards in smaller towns.

The group thanked Mr. Richter for his presentation.

9) Work Groups – Membership Updates

- A) Outreach
- B) Policy
- C) Resilience

Vice Chair Roth stated that they had a Google Excel sheet for signing up for the work groups, which hopefully people responded to.

Ms. Fortson stated that for the Outreach Work group, Chair Swymer, Ms. Maxfield, Mr. Leversee, and Ms. Koning are signed up. She continued that the Policy Work group has Councilor Lake, Ms. Nebenzahl, and Matt Boulton, who will hopefully soon become an ECC member. The

Resilience Work group has Mr. Murphy, Mr. Russell, Mr. Larmon, and Vice Chair Roth. Caroline Sweet is in that group, too, as a member of the public, as well as Peter Hansel. Only one person so far has volunteered to be a leader of a work group, and that is Councilor Lake for the Policy group.

Mr. Redfern stated that he is interested in joining the Outreach Work group. Ms. Koning stated that if there are too many people in a group and another group needs more members, she is happy to switch. She could be in any of the work groups. Discussion ensued. Ms. Fortson noted that Outreach has five ECC members, which is the maximum number they can have without having a quorum; Resilience has four ECC members and two other members; and Policy has two ECC members and one other member.

Ms. Fortson spoke of the need for work group leaders, who would be responsible for coordinating the work group meetings in between the monthly ECC meetings and reporting out to the ECC in some way. It could be in a written form or a verbal update, with verbal updates being preferable. To answer an ECC member's question, Ms. Fortson clarified that work groups could meet on Zoom (or Google Meet), but that would be for the work groups to coordinate on their own, without staff support. Discussion ensued about remote meeting options.

Ms. Fortson asked Vice Chair Roth if they should have the work groups coordinate a meeting before the ECC's August meeting, or if they want to circle back to this at the August meeting. Mr. Murphy asked if there is an agenda for the August meeting. Ms. Fortson replied not at this point. Mr. Murphy suggested dedicating a portion of the meeting to breakouts, and having limited agendas, to talk about next steps, leadership, and those sorts of things. Others agreed. Discussion ensued about whether that idea for the August meeting would work, logistically, if three conversations were happening simultaneously.

Ms. Fortson stated that maybe she could figure out a different meeting location. Discussion continued about possible locations, such as Library conference rooms. Vice Chair Roth suggested having the regular ECC meeting and then having the work groups meet right after, so they could keep their regular meeting location. Ms. Koning suggested the work groups meet before the August ECC meeting, on their own, to simplify it. Councilor Lake agreed and stated that it would be logistically difficult to have break-out groups during the ECC meeting while following the Rules of Order and RSA 91-A. He continued that he thinks each work group should coordinate its own meeting between now and the August ECC meeting. Discussion continued.

 Councilor Lake stated that work groups could meet in person, but meeting online might be easier. He cautioned people to keep the groups as limited as possible if they start emailing each other, to avoid creating a quorum (and thus being subject to RSA 91-A). Ms. Fortson stated that she will email out the ECC roster, which has everyone's contact information on it, along with the spreadsheet that shows who has signed up for each work group.

Ms. Koning stated that this might be a question for the Outreach Work group, but she wonders if the ECC wants to have a presence at the Clean Energy Conference at Peterborough in September. Per an ECC member's question about whether a quorum of ECC members would be allowed to

attend at once, Councilor Lake clarified that it is not a problem for a quorum of members to be at an event or in a location, if they are not grouped together, discussing ECC business and preventing others from listening. Discussion continued about wanting to have a presence at the conference.

WHAT IS "COMMUNITY POWER"?

- Community Power is a State-authorized program that allows the City to bundle together the
 electricity needs of its residents / businesses and put out a bid for electricity suppliers to
 provide the necessary electricity at competitive prices.
- Community Power programs serve as the default electricity supplier within the municipality and offer a vetted alternative to the utility's default service and third-party electricity suppliers.
- Eversource will continue to deliver electricity and manage all billing. The only change program participants will see will be the source and cost of electricity supply, chosen by the City of Keene, using a competitive bidding process.

WHY IS KEENE OFFERING A COMMUNITY POWER PROGRAM?

- With Community Power, communities can make strategic decisions about when to solicit bids, lock in fixed pricing for multiple years, and increase renewable energy content above the existing statewide minimum.
- The goals of the Keene Community Power Program are:
 - ✓ More choice for electricity options
 - ✓ Control / stability of electricity costs
 - ✓ Competitive rates
 - ✓ Increase local renewable energy to help achieve the community's adopted 100% renewable energy goals.
- Keene's program locks in stable, competitive rates to help residents, businesses, and others
 plan for and manage electricity expenses.
- The program also offers four options with varying levels of renewable energy content to give people a range of choices, depending on their personal preferences and needs.
- It is estimated that the first 2.5 years of the program avoided about 15.8 million pounds of CO₂ due to the purchase of NH Class 1 renewable energy. The next contract (Dec 2025-Dec. 2027) is expected to avoid about 19.4 million pounds of CO₂.

HOW MUCH WILL MY ELECTRICITY COST WITH THE KEENE COMMUNITY POWER PROGRAM?

- Starting with meter reads in December 2025, and lasting through the meter read in December 2027 (2 years), the electricity options for Keene's program will range from a cost of 11.2 cents per kilowatt-hour (kWh) to 13.9 cents per kWh.
- For an "average" household that uses ~600kWh in a month, that comes out to about \$66 to \$83 per month.
- To calculate how much your electricity supply will cost with each option, please go to <u>keenecommunitypower.com/calculator</u> and enter your monthly usage in kWh, which can be found on your utility bill.

WHO CAN JOIN THE PROGRAM?

- All electricity ratepayers in Keene including residents, small businesses, and others can join the program.
- All customers eligible for automatic enrollment will receive a notification letter prior to enrollment. This letter will include all program details including program rates and how to participate.
- Those who already have a third-party supplier can opt in to the program at any time.
- If you live outside of Keene, please check with your municipality to see if your community has a program you can join. In addition, Cheshire County offers a program that any resident of the county can join, including Keene residents.

WHAT PRODUCTS ARE OFFERED THROUGH THE PROGRAM?

 The Program has four different products (see below) to provide you with the opportunity to select a specific balance of cost and renewable energy. You can compare monthly costs using the online calculator at www.keenecommunitypower.com/calculator.

HOW DO I JOIN OR LEAVE THE PROGRAM?

- **Joining the program:** To join the program, use the "Enroll/Change" form available on the project website or call the supplier, Direct Energy, at (866) 968-8065. If you are already in the program, you do not have to do anything to stay in it.
 - 1. If you are using a third-party supplier, we recommend that you review your contract before joining the program to ensure you will not have to pay any fees for leaving early.
- Leaving the program: To leave the program, use the "Opt-Out" form available on the project website or call the supplier, Direct Energy, at (866) 968-8065. You may leave the program at any time without penalty.
- **Switching Products:** To switch to a different product, use the "Enroll/Change" form available on the project website or call the supplier, Direct Energy, at (866) 968-8065.
- Re-joining the Program: If you leave the Program, you may re-join at any time; however, the supplier may offer you a price that reflects market conditions at the time. The supplier will ask you to confirm any such price before you are enrolled.

HOW MUCH DOES THE PROGRAM COST THE CITY AND TAXPAYERS?

- The Keene Community Power program is self-funded through the revenues received by participating customers.
- There is no direct cost to the city or to taxpayers; however, there are some indirect costs associated with staff time spent managing the program.

WHAT IF I HAVE SOLAR?


- For residential customers that participate, those on Net Energy Metering 1.0 (or "Standard")
 would continue to receive the same value for their generation as today; however, those on
 Net Energy Metering 2.0 (or "Alternative") would receive less value for their generation than
 today.
- There are additional factors to consider, and we highly encourage each net metering
 customer to make their own decision. Please see our detailed <u>Net Metering FAQ</u> to help with
 your decision, available online at <u>www.keenecommunitypower.com</u>.

WHAT IF I PARTICIPATE IN THE ELECTRICITY ASSISTANCE PROGRAM?

- Customers who receive a discount on their electricity bill through the Electric Assistance Program (EAP) will continue to receive their benefits.
- Budget billing customers will continue to receive budget billing for the Delivery Services portion of the bill.

WHO OPERATES AND MANAGES THE PROGRAM?

- The Community Power Program is governed by the Keene Community Power Plan, adopted by Keene City Council and approved by the NH PUC. This plan designates oversight and management of the Plan to the City Manager.
- The City has hired a consultant team, consisting of a local NH company (Standard Power)
 and a national company with extensive experience running similar programs in other states
 (Good Energy). The consultant team manages certain activities under the program, including
 managing the supply procurement process, public engagement, interacting with Eversource,
 and monitoring the supply contract.
- The competitive supplier, Direct Energy, provides power for the program as well as customer support including staffing a toll-free number for customer questions
