Baker and Taylor, the Library's primary print book resource, has gone out of business. Until the new company is set up (Ingram), we will be relying on Amazon for patron requests. This has increased work for staff in a variety of ways.

Judy asked about Makerspace availability. There is limited staffing, but opening hours remain reliable. Judy further inquired if the room is ever crowded and Susan said no, that there is a nice flow to the room, and staffing seems adequate. However, she does expect engagement to accelerate as the holidays approach.
