Re: Revision Energy Solar Development at Keene Dillant-Hopkins Airport

Dear Chair Self.

I am writing on behalf of the Keene Dillant-Hopkins Airport Development and Marketing Committee (ADMC) to express our strong support for Revision Energy's proposal to construct a 5 MW solar array at the south end of the airport.

This project represents a transformative opportunity for the City of Keene, the airport, and the surrounding region. Upon completion, the solar array will:

- Advance the City of Keene's goal of achieving 100% renewable energy for municipal operations by 2030.
- Fully meet the airport's electrical demand through on-site generation and group net metering.
- Provide long-term revenue to the airport through a land lease, helping to offset operating expenses.

The facility is expected to produce approximately **6,616,576 kWh of clean renewable energy annually**, enough to offset 100% of the City's municipal electricity accounts via group net metering. Also, it is anticipated the facility will preclude approximately **3,220 metric tons of CO₂ emissions per year**, equivalent to:

- Eliminating emissions from 7,437,885 miles driven by an average gasoline-powered passenger vehicle.
- Avoiding the burning of 3,244,422 pounds of coal.
- Matching the carbon sequestration of 2,930 acres of U.S. forests annually.

The proposed site is uniquely well-suited for this development. It is already cleared, requires no tree removal or significant grading, and has limited alternative uses due to Federal Aviation Administration (FAA) height restrictions and airport approach protection zones. A 2022 Airport Land Use Compatibility Study conducted by McFarland-Johnson, Inc. specifically identified these parcels as "ideal for a solar farm" in support of the airport's and City's sustainability objectives.

The Keene Dillant-Hopkins ADMC wholeheartedly supports this environmentally responsible and financially beneficial project. We urge the Swanzey Planning Board to approve the application and thank you for your thoughtful consideration.
